SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The Oshakati Town Council reserves the right:

- (a) to split the contract as per the lowest evaluated cost per lot; and
- (b) to accept or reject any quotation or to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Form of bid

This is a hard copy bid submission and responses must be submitted to the delivery address stated on the cover page. Bidders are required to complete the envelop cover page and paste it on top of their bid envelop.

3. Preparation of Quotations

You are requested to quote for the works mentioned in Section III, by completing, signing, and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration, where applicable;
- (b) the Priced Activity Schedule in Section IV;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment as deemed appropriate.

You are advised to carefully read the complete Request for Quotations document, including the Special Conditions of Contract in Section VII, before preparing your Quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

4. Validity of Quotations

The quotation validity period shall be **60** days from the date of bid submission deadline.

If a bidder has already lodged a submission, it may revise that submission and resubmit it no later than the extended submission closing time.

11. Addenda

Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

17. Technical Compliance

Oshakati Town Council has one landfill site where the service of the Bulldozer shall be required from time to time.

The successful Bidder/contractor will be expected to push and level the site on request by Council on provision of purchase order to bidder.

The rate for hiring the equipment shall be as follows:

- Transport of equipment per kilometer
- Wet Rate
- Rate per hour
- Labor/operator cost

The contractor shall make the equipment available whenever Oshakati Town Council request for the service. Otherwise, successful Bidder has the responsibility to ensure that the work to be done with Bulldozer is done by providing the Bulldozer.

Tax invoice shall be submitted to Council upon completion of work as per schedule of prices, with purchase order attached. Council officials will supervise the operation and certify the completion of work for payment.

Note: Preference shall be given to the local based Bidder, because the Bulldozer must be available whenever needed with five (5) working days.

1. PENALTIES

The events or malpractices for which penalties shall be applied, and the corresponding amounts of the penalties, are as follows: -

- a. Failure by the Contractor to provide the Bulldozer within five (5) days or part thereof during the agreed operating days:
 - The Contractor shall be served with **first written warning letter** for not complying with the agreement.
